Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets with a 7% decrease per year. We project that carbon emissions will decrease over the next five years to 10,16 tCO₂e by 2029. This is a reduction of 40%

Carbon Reduction Projects

Ortivus UK Ltd. is working in Carbon Reduction projects related to the following areas:

- Company vehicles
- Product transports
- Customer support
- Internal personal transports
- Offices & others

Company vehicles: Current company vehicles will as the gradually are replaced be replaced with electrical vehicles.

Product transports: Unnecessary shipments of faulty products or repairs are reduced by doing more repairs locally in house than being sent to subcontractors for service or repair.

Customer support: With new and digital technique service and upgrades can be done remotely to a larger degree than earlier reducing transport of devices to Ortivus premises or avoiding that Ortivus personnel needs to travel to a customer to do upgrades on site. As a result, the distance driven by one of our service vehicles has decreased from 25,000 km in 2020 to 15,000 km in 2024, a reduction of 40%.

Internal personnel transports: Transports to and from our offices has been reduced as a



combination of working from the office or from home has been implemented whereas a mix is applied based on a general principle of 3 days in the office and 1-2 days per week from home.

Offices & others: An open desk policy has been introduced as many employees work from home part time. This has the effect of that the usage of office space is optimized and thereby reduction of unnecessary office space and heating of office can be reduced.

Physical meetings with customers should initially be done using Teams why long transports for meeting and or presentations are reduced. Ortivus UK Ltd. is also introducing an online training package for our range of defibrillators and MobiMed which also reduces the need for training on site both in the initial phase of a installation projects but also that can be used as follow up or introduction for new employees at the customer site.

In the future we hope to implement further measures such as: Certification according to ISO 140001
